9 TREE REMOVAL WAS DISCUSSED DUE TO FENCE DAMAGE AT THE VILLAGE CEMETERY IN THE SPRING. FENCE REPAIR COST WAS \$1158.00. DEB MADE A MOTION TO TAKE \$3000.00 OUT OF INVESTED FUNDS TO TAKE DOWN (5) TREES AT VILLAGE CEMETERY, BOARD APPROVED MOTION. CALVIN ALEXANDER HIRED FOR TREE REMOVAL WORK.

10 MELVIN INFORMED BOARD THAT THE TRAIL COMMITTEE WAS ^{GOING TO ASK} ~~ASKING~~ FOR PERMISSION TO ESTABLISH (3) THREE PARKING SPACES AT ENTRANCE TO VILLAGE CEMETERY. MORE INFO NEEDED. WILL RE-DISCUSS AGAIN AT SPRING MEETING.

11 BOARD VOTED TO REQUEST \$25,000.00 FROM FEDERAL MONIES COMING TO CABOT FOR REPAIRING BROKEN, TOPPLED, AND LEANING STONES. PROPER MAINTENANCE OF CEMETERIES SHOWS RESPECT FOR PREVIOUS GENERATIONS.
