- 1. Call Meeting to Order the meeting was called to order at 6:53 p.m. by Mike Hogan, Chair

- 3. Approve Minutes from SB Minutes from December 6 budget meeting A motion was made by RD with a second by Skip to approve the budget meeting meetings, with Fred and Ian abstaining as they were not at the meeting. Motion carried. December 6 SB meeting RD moved that we accept the minutes with a second by Skip.
