At next meeting we will have a timeline for grant-related and non-grant related work. Michael will take the lead on drafting.

Chuck will informally check with the four landowners about permission for a trail from Pat DiStefano on South Walden Rd to Stefanie Caffin on Rt 215.

Chuck will place the grade stakes (purple trail marking) in the middle of his field for the winter.

We will re-evaluate the draft Town Forest map and the individual-colored trails.

Monique mentioned that brush was cut on the side of the gate on the McQueeney trails on the Cabot Plains end. We do not know why this was done and should find out before we install a metal gate.

Chuck said that Don Mitchell will be plowing by Elm Street Cemetery like last year.

Grant Update

We have responded to Dept. of Vermont Forests, Parks & Recreation regarding the questions they had about our grant application. We are hoping to get a final draft grant agreement that we can bring to the Select Board in January.

A LVRT grant was awarded by Agency of Transportation to the six towns (St. J to Hardwick) to develop trail parking options, an amenities plan, a safety plan, and wayfinding to points of interest that are off the trail. Gary is attending monthly meetings. The next step is to hire a consultant to do the work.

Trail Maps and Apps

Chuck thinks that the best way to advertise our trail network is on Trail Finder. This is not an app but a web site that has a large inventor of trails in Vermont and NH. Content would be under our control and not crowdsourced like many of the apps. Chuck will follow up with the administrator of Trail Finder to get more information on the process of posting trails. Gary will check with the LVRT group of towns on experience with trail apps.

Public Outreach

A trail update article for the Cabot Chronicle was submitted. **Chuck said he would periodically post on Facebook and to send him any messaging to post.**
