- 3. Set tax rate for FY25 A motion to approve the municipal tax .5158 by Fred with a second by Mike, motion carried. A motion was made by RD with a second by Karen to approve the Homestead Tax Rate is \$1.3398, Motion carried. A motion was made by RD with a second by Fred to approve the total Homestead Residential tax rate of \$1.8556, motion carried. A motion was made by RD with a second by Fred to approve the non-homestead tax rate of \$1.3199, for a total of \$1.8357, motion approved.

 - c. Overview of West Hill Pond there was more damage after this flood. The dam needs to be drawn down. Reviewed maps of dam. It is moving to the top level of danger. The State passed statutes but hasn't promulgated any rules. At this point we are trying to get a deeper analysis. There is no decision we must make at this time. It will affect infrastructure. Can we compel the owners to do anything. The pond was drained in 2003. We must draw it down, but we have no authority to do this as it is privately owned. The engineers hope to have a public meeting to answer questions regarding the repair of the dam. We are limited in what we can do. What about West Hill Pond Association? Mike will reach out to other sources to see what we can do.
